By implementing the following policies, we commit to the continual improvement of our performance in all areas, supported by continual development of the management system.

Corporate Responsibility

Compliance with national and international legislation and conventions is an integral part of this. All employees of Maersk Supply Service are obligated to adhere to the following policies under the main focus areas within our corporate responsibility.

Health and Safety

Our policy is to conduct activities in a manner that first and foremost protects the health and safety of our employees, client representatives and subcontractors. We strive towards preventing all personal injuries and ensuring a healthy and resilient workforce. We do this by empowering our people, encouraging critical thinking and focusing on managing our critical risks. We consult and focus on the active participation of our workers in order to enable safer ways of working, and emphasise that we all have an obligation to stop work if considered unsafe, to prevent our colleagues from taking unsafe actions.

Diversity & Inclusion

We believe that a diverse and inclusive culture will foster creativity, innovation, new ways of thinking and an environment in which everyone can feel engaged to reach their full potential. We aspire to create an inclusive culture where employees from every background can strive for skill development and growth, both on- and offshore. In 2020, Maersk Supply Service signed the Charter for More Women at Shipping, committing to increasing gender diversity offshore and onshore.

Environmental Protection

We, at Maersk Supply Service, are committed to protecting and conserving environmental resources whilst carrying out our operations in susceptible marine landscapes.
